



## *Know All Ye Men By These Presents*

*I, KaSiKa RQC StoneFort YaShar'al, De jure Sovereign Chief and Patriarch of Sha'Kori AyeliUdotlvsy Yi'srael, an International Recognized Tribal Nation-State, pursuant to the 1933 Montevideo Convention, on this 9th day, in the 12th month, in the year of KaWah, 2014, hereby Anoint, Appoint, and Commission, Dr. Sea Ven Gadoche YaShar'al as, KaSiKa TzeDeKah (Chief Justice) for the Baryath Abar'Rishoni Tribal Court and Sovereign Government of Sha'Kori AyeliUdotlvsy Yi'srael, for a life tenure;*

*KaSiKa Tze'DaKah, Dr. Sea Ven Gadoche YaShar'al shall perform the following functions, but not limited to those enumerated herein, for and in behalf of the Royal KaSikees, and the Tribal Nation-State, its agencies, entities, and instrumentalities,*

*Thereto:*

- 1. Chief Legal Advisor to the Tribal Nation-State's KaSikees and the Tribal Nation-State; not limited to affairs of the Tribal Nation-State and International Relations;*
- 2. Chief Counsel-At-Law for Tribal Nation-State, its agencies, entities, and instrumentalities; not limited to affairs of the Tribal Nation-State and International Relations;*
- 3. Establish and operate a functional judiciary as a viable Tribal Nation-State organ for the preservation and enforcement of Tribal Nation-State's sovereignty; inclusive of the establishment Office of Records: Tribal Nation-State identification cards, Tribal Nation-State Citizen Rolls and Activities, Marriage License, Birth Certificates, Baptism Certificates, Driver's License, License Plates, Deeds, Trust, Cases, Law Library, et al, Emergency Services, as well, Administration Systems and Operations, Management Procedures, Checks, and Balances, et al, for the proficient, equitable, and righteous dispensation of KINGDOM law and justice;*
- 4. Ensure Tribal Nation-State Charter, Constitution, and Bylaws remains a viable living document;*
- 5. Ensure Tribal Nation-State Citizen Handbook remains consistent with Tribal Nation-State's Living Charter, Constitution, and Bylaws; inclusive of Code of Conduct's alignment with Scriptural Laws;*
- 6. Provide a righteous spiritual working environment for the proper equipping of the qualified personnel; inclusive of the hiring/firing, mentoring and training of Counsels-at-Law, Paralegals, Legal Secretaries, Record Clerks, Bookkeepers, General and Operations Managers, Chief Clerk of Court, IT, Tribal Nation-State Clerk, Tribal Nation-State's Commissions and Committees, et al;*
